The answers are clear and they elaborate not only on the correct answer but also in showing why the other answers were incorrect, while explaining concepts in a brief but rather complete way.

Repetition of the same old questions, misleading the buyer and totally unjustified higher cost. Recommendation: Buy the oldest edition which is as good as the latest.
